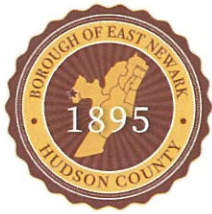

However, Borough Clerk Harris stated that at the Mayor's discretion; the meeting could be changed to: (1) allow for a virtual option utilizing Zoom; or (2) being all virtual depending on the severity of the COVID-19 pandemic and if changed to allow a virtual option; or conducting an "all virtual" meeting that information on how to access the meeting via Zoom shall be provided.
